FICFE Composition Contest 3rd Edition | 2024 in tribute to Rocío Sanz Quirós - Costa Rican composer -

Original Works and Popular Music
Arrangements
for Female Choir and Children's Choir

The Contest is aimed at composers and arrangers with no age limit.

Its main objective is to promote the work composed for the voices of female choral groups, stimulating the composition of original works and arrangements, which present innovative proposals, exploration of vocal and expressive resources, the relationship between text and music.

The contest will consist of three categories:

Category A | Original composition from 3 female voices a cappella or with instrumental accompaniment.

- 1st Prize: 300 USD (three hundred US dollars), certificate and edition of a digital booklet together with all winning works, chosen by the jury.
- 2nd Prize: 150 USD (one hundred and fifty U.S. dollars), certificate and edition of a digital booklet together with all winning works, chosen by the jury.

Category B | Choral Arrangement of Popular Music from 3 female voices a cappella or with instrumental accompaniment.

- 1st Prize: 300 USD (three hundred US dollars), certificate and edition of a digital booklet together with all winning works, chosen by the jury.
- 2nd Prize: 150 USD (one hundred and fifty U.S. dollars), certificate and edition of a digital booklet together with all winning works, chosen by the jury.

Category C | Original Composition or Choral Arrangement of Popular Music for children's choir up to 3 voices a cappella or with instrumental accompaniment.

- 1st Prize: 300 USD (three hundred US dollars), certificate and edition of a digital booklet together with all winning works, chosen by the jury.
- 2nd Prize: 150 USD (one hundred and fifty U.S. dollars), certificate and edition of a digital booklet together with all winning works, chosen by the jury.

REGISTRATION PROCESS

The deadline for submitting the works will be Sunday, October 20th, 2024.

The registration fee is 25 USD (twenty-five U.S. dollars) for each work submitted...

Shipping costs, taxes and exchange rates are the <u>responsibility of the participant</u>.

The registration fee is <u>non-refundable</u>.

STEPS TO BE FOLLOWED

- 1) Compose a work according to the **Terms & Conditions** of the **FICFE Composition Contest**, according to the established categories and assign yourself a pseudonym.
- 2) Pay the registrarion fee.
- 3) Download the **Affidavit** (as explained below).
- 4) Complete the registration form.

If you are <u>submitting more than one work</u>, **for each of them** you must:

- Pay the registrarion fee.
- Assign yourself a different pseudonym.
- Download, complete, print and sign a copy of the affidavit (as explained below)..
- Fill out a separate form.

IMPORTANT

The reception and organization of the competing works will be handled by the **FICFE** Organization (people completely unrelated to the jury), so the anonymity of each participant will not be at risk.

Different works with the same proof of payment will be rejected.

All participants will receive an email from the Organization confirming receipt of the material.
